VOLUNTARY ANNOUNCEMENT PURCHASE OF SHARES IN THE COMPANY BY DIRECTORS

This announcement is made by Yuxing InfoTech Investment Holdings Limited (the “**Company**”) on a voluntary basis.

Reference is made to the announcement of the Company dated 22nd December 2017 in relation to the purchase of shares in the Company by directors.

The board of directors of the Company has been informed by the Company’s directors, Mr. Li Qiang (“**Mr. Li**”), executive director and chairman of the Company and Mr. Gao Fei (“**Mr. Gao**”), an executive director and chief executive officer of the Company that on 22nd December 2017, they have further acquired ordinary shares of the Company (“**Share**”) in the open market. Mr. Li purchased a total of 1,000,000 Shares at an average price of HK\$0.831 per Share and Mr. Gao purchased a total of 18,000 Shares at an average price of HK\$0.811 per Share (together, the “**Purchases**”).

Based on the latest disclosure of interest form filed with the Company, Mr. Li is the sole shareholder and director of Capital Melody Limited which holds 32.09% of equity interest of Cloudrider Limited which in turn is interested in 450,357,200 Shares. Immediately before the Purchases, Mr. Li was personally interested in 1,744,000 Shares. Mr. Li has total personal shareholding in the Company increased to 2,744,000 Shares after the Purchases, representing approximately 0.15% of the total issued share capital of the Company.

Immediately before the Purchases, Mr. Gao was personally interested in 2,172,000 Shares. Mr. Gao has total personal shareholding in the Company increased to 2,190,000 Shares after the Purchases, representing approximately 0.12% of the total issued share capital of the Company.

Mr. Li and Mr. Gao feel confident with the Company's business outlook. Mr. Li and Mr. Gao does not rule out the possibility of further increasing their shareholdings when they feel appropriate.
